I believe that the solutions already discussed are now being implemented. First the Collection of data and facing the problem. Second, the training of teachers in common core Implementation, Third, the need for intervention services. The board needs to fully back Management plans and include details in the LCAP budget.

- 10. What can the district to decrease the dropout rate? In the year 2013, we formed a drop out Committee to get the data about how many students actually dropped out. The State of California reported that 7.5% of our students dropped out. What Farris Sabbah found in his excellent research was the state pertained to high school students only. When taken in total, the dropout rate was actually around 20%, when middle school students were included in the count. The profile of a potential drop—students that did not have English skills (see question 7) The importance of the study must be recognized. It forms the basis for program planning.
- 11.What do you think the district policy should be about parent choice regarding underperforming schools. I have always been in favor of parent choice—in was the justification for charter schools. However, it prevents parents without transportation or resources, so it becomes not a true choice. We are governed to some extent by state regulations. We need to improve our schools so we have no Underperforming schools.

#### 12. What is your stance on charter schools?

When PVUSD had no charters, I believed that parents should have choices of different types of schools because each child is different. I saw this in my two children who grew up in the PVUSD. But, my two children went to our public schools, no charter education, colleges, and benefited from our schools.

As a school board member, I am not convinced that charter schools have met the academic standards. They predicted. I question the independent charter model versus the dependent model. The charter Schools cannot take away from the rest of the district, funding, facilities, personnel.

- 13. What is your approach to minimizing cultural conflicts while honoring diversity of our student Population. I believe that extra-curricular activities bring people together----sports, music, dance And this is why we must encourage funding---not keep cutting these programs every time we have To make adjustments.
- 14. How can we recrult and retain experienced staff?
  We can change our bargaining methods to adjust benefits/salary to match our staff needs.
- 15. How will you obtain input from faculty, staff, and others in developing policles and making Decisions? As I always have. I attend site council meeting, meet with parents. I am fortunate that Parents feel welcome to meet with me, or call me when they have a concern. Football games, concerts, church activities, clients are ways I keep in contact..
- 16. Do you have a special area of interest that you would to incorporate into your as a school board Member? Yes. Career Tech Education (CTE). Not all kids are going to college. We need to prepare Students for future career choices.
- 17. What Is your experience and knowledge in collective bargaining.?

Districts must have a bargaining agent. The choice of the bargaining group is strictly up to its members. The board has nothing to do with this selection process. The collective bargaining Process then follows state and federal rules and regulations. As we adhere to this process, we can Make changes such as making fact-finding earlier. There are other changes that might be made.
