Pajaro Valley Unified School District (District)


Pajaro Valley High School Modified Block Schedule for the 2025-2026 School Year

This agreement negotiated between the District and PVFT applies only to the PVFT unit members assigned to the Pajaro Valley High School in relation to the implementation of the modified block schedule beginning 2025-2026.


Understandings:

1. The modified block schedule will consist of 7.5 hour work days Monday-Friday.
 - a. The work hours will be as follows:
 - i. Monday - Thursday 8:15am - 3:45pm
 - ii. Friday 8:15am - 3:45pm
2. The bell schedule is attached
 - a. See Exhibit A- PVHS 2025-2026 Bell Schedule
3. All teachers who teach .80FTE or more will be assigned an Advisory class according to the PVHS bell schedule.
4. The structure and function of the Advisory periods will be coordinated and logistically set up via the site leadership team (Cabinet).
5. The Cabinet will develop a monthly collaboration schedule for Fridays in accordance with the CBA.
6. Every effort will be made to work with the Special Education department to ensure that they are assigned one of the advisory periods to work on case management.
 - a. This schedule should be set in consultation with site administration and the Special Education Department.
7. The option to teach a zero period may be offered to PVHS teachers if FTE is available and the course meets the requirements to be offered as a 0 period.
8. A teacher who teaches a zero period will have that period considered in their schedule as an extra .20 FTE for which they are paid according to the contract.
9. This MOU does not constitute past practice and is not considered precedent setting.
10. This MOU is for the 25/26 school year.

11. Addendums to the MOU may be added during the 2025-2026 school year only after reaching mutual agreement with the District and PVFT.
